### **Smart Cities Mission**

Cities are engines of growth for the economy of any country. As per Census 2011, nearly 31% of India's current population lives in urban areas and contributes 63% of India's GDP. With increasing urbanization, urban areas are expected to house 40% of India's population and contribute 75% of India's GDP by 2030. This requires comprehensive development of physical, institutional, social and economic infrastructure. All are important in improving the quality of life and attracting people and investments to the City, setting in motion a virtuous cycle of growth and development. Development of Smart Cities is a step in that direction.

In the approach to the Smart Cities Mission, the objective is to promote cities that provide core infrastructure and give a good quality of life to its citizens, a clean and sustainable environment and application of 'Smart' Solutions. The focus is on sustainable and inclusive development and the idea is to look at compact areas, and to create a replicable model which will act like a light house to other aspiring cities. The Smart Cities Mission of the Government is a bold, new initiative. # **Major works of Civil department**

Civil Department play a major role to provide infrastructure and maintenance of public facilities. In continuation of better service and facilities we have completed following projects recently:

- 1. With investment of Rs. 13,00,000.00 (Rs. Thirteen Lacs) from Nagar Nigam fund we make 14 Nos. of Community Toilet at Ward No. 35 with help of Sulabh International.
- 2. Public facility toilet at Traffic Garden , Kota with all modern facility with a investment of Rs. 9,00,000.00 (Rs. Nine Lacs) from Nagar Nigam Fund.
- 3. Ten Seated Deluxe Public Toilet made by Nagar Nigam Kota at Rangbari Road with a investment of Rs. 24,00,000.00 (Rs. Twenty Five Lacs)
- 4. New shelters are made by Nigam Nigam to facilate the public under National Urban Live hood Mission (NULM) at New Medical College (66.83 Lacs), Bus Stand, Nayapura (Rs. 73.45 Lacs) and Bhimgang Mandi (78.55 Lacs) where 182 person can stay at a time.







With Swach Bhart Mission programme Nagar Nigam plans for Public Toilet at following areas:

Nagar Nigam , Kota plans to provide toilet facility to residents houses with a target of 12150 house hold. We have selected 2163 houses with a fund of Rs. 8000.00 each from Government of India under Swacch Bharat Mission.

## High speed Wi-Fi to make Kota Nagar Nigam first Smart zone in Hadauti

KOTA; High Speed 4G Wifi facility will be available at Kota Nagar Nigam zone by next month. Gadgets like Computer, mobile phones and tablets will be running very fast and five movies can be downloaded within just half an hour.

The discussion regarding the same has been going on between Nagar Nigam officials and Reliance Jio Infocom, the only high speed 4G internet Service provider. Now, only some necessary equipment installation and initial investigation work remains, hopefully this work would be done by the next month.

Fourth generation internet facility (4G) LTE (Long term Evolution) Technique is latest in the world and has unique role in speed. For example, with the internet we are using now, the downloading time for one movie will take one and a half hour to two hours and is time consuming due to buffering, etc. But on 4G network, the work will be done within 5 to 7 minutes with High speed net without any buffering time.



All these efforts are a part of the Prime Minister Narendra Modi's pet project "DIGITAL INDIA" where 4G LTE technique will play a significant role. Reliance Jio has been working speedily in the state so that services can be officially launched in Rajasthan by December along with rest of country. Officials of the Reliance Jio said that more than half of the work has been completed in Hadauti. If legal permissions are allotted for installing tower, then this work will be completed more speedily.

# **Special Cleaning Work Campaign**

#### A. Door to Door Garbage Collection

As per state Government guidelines tenders were invited for the purpose of garbage collection from door to door of various cities, the 184 Nagarpalikas were divided in 111 clusters. But in most cities bidders didn't participate in the bid. Now as per state government's guidelines new RFP is to be issued by making partial changes in RFP issued earlier based on the needs at local level. For this purpose RFP issued in other cities is to be studied and after discussing with agencies working in this area proposed RFP to be issued soon.

#### **B. Solid Waste Management (Feasibility Report)**

As per state government guidelines tenders were invited for "Preparation of Feasibility Report Under Guidelines of Solid Waste (Management and Handling) Rules- 2000 on the basis of "Waste to Energy" at kota city . For this work one bid is received whose technical and financial bid has been opened, after negotiation the rate of 18.00 lakhs is received. Work order is under process.

#### -Cleanliness in Municipal Towns

- (i) Earlier as directed by the state government Special cleaning campaign was run in Kota city in which 7262 ton garbage was picked up. Photos are attached.
- (ii) In present Municipal Corporation of Kota has completed cleaning of almost all major drains of Kota city in terms of cleaning prior to rain. Various drains located at inner slums of the city have been cleaned. Years old trash what were placed in empty plots are being taken away. Other than this cleaning and repairing of various parks, toilets and urinals have been started. Actions like Cash fine penalty and chalan are being imposed on littering.
- With special work plan in July month night-time cleaning is being taken place in city's prime markets like station, shopping centre, Gumanpura, Raipura. For this job separate 30 labourer and 3 tractor trolleys are in function. In present 600 tons of garbage is picked up per day in place of 450 tons daily by municipal corporation Kota.

#### 3- Dumping Yards

In present the trenching ground of Municipal Corporation, Kota is located at Nanta road. Now Biological Park's permission is given by the central near the site, thus there is a need of shifting this ground on an alternative location. Urban Improvement trust of Kota has marked a land near jagpura on jhalawar road.

Shortly after completion of necessary formalities necessary actions will be taken.

1- Property connection: - for sewerage property connection state government approved 500 lakhs by letter no. 2670 dated 22.03.2015. An expenditure of 244 lakhs has been made for this work.

Total proposed connection - 4700 Completion of connection to sewer line - 1276

Completion of chamber building but connection will be issued by UIT after completion of

### **National Urban Livelihoods Mission-(NULM)**

Ministry of Housing & Urban Poverty upaashpan, Golden Jubilee Urban Employment Scheme promoted by the central government to make fiscal 2014-15 was restructured and named National Urban Livelihoods Mission (NULM). Just like in NULM SJSRY selected BPL families to be benefited.

(SHG) and their composition is emphasized. According to which minimum one member (Women will be given priority) from each urban poor family necessarily shall be made a member of SHG. In Self-help group members 10-20 together as a group shall collect their small savings and group members together to do the transactions and meet in a meeting conducted on periodic basis. SHGs 10-20 at ward level will together create their own composition which will be known as Area Level Federation (ALF) and further all ALF together at City level will create their composition known as City Level Federation (CLF). From every SHG 2 members will be of ALF and each member of ALF will be a member of CLF. Registration is compulsory for ALF and CLF.

**Goal-**Under this component Self Help Group (SHG) make 565 goals in 2015-16, 423 Self Help Group to be issued revolving fund, including 10-20 Self Help Group (SHG) 43 Area Level Federation (ALF) be made, 27 Area Level Foundation (ALF) to be issued revolving fund, all Area Level Foundation (ALF) together at city level will make City Level foundation (CLF) and 1 City Livelihood Center (CLC) to be achieved. SHG, ALF and CLF etc formation, their growth, bank linkage and all other activities associated with it, 14 ROs had to be selected in the year 2014-15. In which following 3 ROs have been selected:

- 1. Voice Institute Jaipur
- 2. Search and Service Society Jaipur
- 3. Ramkrishna Vidya Education Committee Atru Jaipur

The above three institutions signed the work order which has been issued. The work of 3 institutions is in progress. In this regard letters have been issued to the institutions to present a progress report. Release No. 2015-16 for the remaining 11 ROs NNICO/NULM/2015/5098-5101 had been released dated  $19^{th}$  june 2015. According to which on  $20^{th}$  july 2015 the desire is to invite expressions.

#### 1. City Livelihood Center:

Under this component Nagar Nigam kota has been assigned a goal of 1 CLC formation. The haat market for the rural to develop in the form of CLC as well as the district center was written on date 12<sup>th</sup> February 2014. District industries center has sought guidance from the industry department officials. In this regard a letter was sent to respected commissioner, jaipur to transfer the rural haat baazar by nagar nigam.

Support to urban street vendors (SUSV) Under this component Street vendors capacity, cooperation in development of Microenterprises, The financial assistance to be available, providing social facility, and other work includes. The time-bound schedule of Street Vendors of social economic survey to register them and issue them identity cards etc includes. ### At a Glance

Kota received Municipal corporation post since 1993. After this Municipal Corporation has made 5 Boards. Municipal Corporation Kota is made from 65 wards. It includes 35 extended district areas of earlier times. Thus the no. of ward parshad in Municipal Corporation are 65. Mahesh Vijayvargiya is a present Mayor in Municipal Corporation. At present the population of Municipal Corporation Kota is 1001365 and area is approx 100 sq. km.

The budget of Municipal Corporation Kota for financial year 2015-16 is Rs. 298 crores, 50 lakh and 26 thousand. The estimated revenue of corporation is 268 crores, 40 lakh and 26 thousand. The provisions of various expenses are as follows:-

Cleaning amount -92 crores 50 lakh 52 thousand, Electricity amount -10 crores 2044 thousand, cowshed amount -4 crores, 65 lakh 26 thousand, Garden amount -8 crores, 92 lakh 49 thousand,  $13^{th}$  finance department -10 crores, Development amount -34.50 crores, State finance department -24 crores, IHSDP -1.50 crores, Nirband donation and RUDF -20 crores

**Special Pension Scheme:** - Municipal Corporation has received total 33,444 applications of camps and follow up Under the special Pension Scheme. From them 33,084 applications has forward to officer for online permission. Thus, In Municipal corporation area almost 33000 new families received profit under this scheme. 3560 Pension forms has forward to the officer after online permission by Municipal corporation and almost 5500 forms are in online process which as soon as possible will be accepted and forwarded and approx 2000 pension forms which are in process have been returned by officer.

Maintaining cleanliness: - Nigam distributed in 15 sectors for maintaining cleanliness. There is 1 health officer, 1 chief health inspector, 11 health inspectors are working for cleaning in Nigam. Basically in Municipal corporation area 1125 permanent employees are working on contract basic for maintaining cleanliness. Generally roads, streets, drains, toilets etc cleaning work are conducting by these employees. Nigam has 5 J.C.B, 7 dumper, 2 Sewerage machine, 3 auto jeting machines, 7 Auto rickshaws, 6 Tipper, 3 refuge collector, 14 dumpher plesar for garbage transport maintenance after cleanliness. Beside it work is going on to take on rent 6 J.C.B, 12 dumpers and 68 tractor-trolleys. Garbage is picked out by 197 J.C.B and 267 tractor trolley from garbage points and approx 500 ton garbage picking daily from 105 dustbins. Cleaning work of 9397 sewerage main hall and sewerage line is going on by Municipal Corporation which made by Rajasthan Housing board and Municipal Corporation Trusts. 101 in the urinal and 205 Toilets are using in Municipal corporation area. Periodically generated in the city Misquotes deices effectively prevent fogging machine daily from 3 in the municipal ward wise fogging being.
